6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Ensure adequate ventilation. Use personal protective equipment.

7. HANDLING AND STORAGE

Normal Handling: Avoid breathing mist, if any should be formed. Minimize contact of liquid with eye, skin, and clothing. Use good personal hygiene and housekeeping.
